STUDENT INFORMATION

Student Conduct: Maverick Driving Academy takes operating a motor vehicle seriously. Students are expected to conduct themselves in a professional, responsible, and appropriate manner at all times regardless if in the classroom or training vehicles. Students can be dismissed for misbehavior.

Requirements: Students will be accepted into the program at the age of 14 years and 10 months for the 8-hour classroom session; however no student will be allowed to operate a motor vehicle until they have reached their 15th birthday. As required by law, students must have in their possession while driving, any corrective lenses required by the Department of Motor Vehicles.

Tuition and Fees: The fee for 14 hours of instruction is \$300.00. The program includes an *8-hour classroom session and six (6) hours of driving (generally three (3), two (2) hour driving sessions)*. Students who do not show up for their scheduled drive will be rescheduled and subject to a \$25.00 rescheduling fee. Any applicable rescheduling fee must be paid prior to the student being rescheduled. All fees must be paid in full prior to receiving driving certificate. There will be a \$35.00 service fee for any returned checks.

Refunds: After completion of the 8-hour classroom instruction, students are not eligible for a refund. However, a prorated refund may be given for any remaining behind-the-wheel instruction.

Course Certificate: Students who successfully complete the 14 hours of instruction offered by Maverick Driving Academy will receive a certificate from the school and a signed form PDLA from the South Carolina Department of Motor Vehicles, showing successful completion of a driver's education class.
